

# Obiga meets Busia traders

"With all the measures you have put in place, I would have opened the market now if I had the powers," the state minister for internal affairs, Obiga Kania, told Busia traders on Wednesday.

The traders operate at the Busia produce market. He, however, said they will seek consultation from the national COVID-19 task force, which ordered the closure of border markets.

The decision to close the markets, Obiga said, was not his directive, but he only announced it, adding that it affected all the border points in the country.

The traders are grappling with selling their grain, which is stuck in the stores. They say some of it has started rotting.

He told traders during a meeting held at Chango Macho Hall at the Busia district headquarters that he would get back to the Resident District Commissioners after consulting with the national task force.

Busia municipality mayor Hassan Bwire Opio said the closure of the markets had negatively impacted the area, adding that the council was grappling with the challenge of
